THIS RELEASE AND WAIVER OF LIABILITY IS APPLICABLE ONLY TO DAMAGES ARISING FROM, OR RELATED TO, THE EXPOSURE OR TRANSMISSION OF THE CORONAVIRUS AND OTHER COMMUNICABLE DISEASES.

In consideration for the SKYVIEW HEIGHTS HOMEOWNERS ASSOCIATION, INC. (“Association”) permitting my child to use the Association swimming pool, tennis court, and playground (together referred to hereinafter as the “Amenities”), I HEREBY:

1. **Acknowledge that there may exist a risk of exposure to the Coronavirus (“COVID-19”) and/or personal injury associated with my child’s usage of the Amenities;**
2. **Voluntarily assume any and all risk and danger associated with my child’s voluntary choice to use the Amenities. My child AGREES TO SCRUPULOUSLY FOLLOW ALL Rules in this Waiver and all posted rules, ESPECIALLY THOSE RELATED TO COVID-19;**
3. **RELEASE, DISCHARGE, AND PROMISE NOT TO SUE**, the Association and/or any of its members, officers, employees, TAYLOR MANAGEMENT COMPANY (“Management”) and of the Association’s or Management’s agents (hereinafter the “Releasees”), for any loss, liability, damages, or costs whatsoever arising out of or related to any loss, damage, or injury (including death) to my child or property arising out of my child’s use of the **Amenities. I UNDERSTAND THAT I AM GIVING UP MY CHILD’S RIGHTS BY SIGNING THIS RELEASE; ESPECIALLY MY CHILDS RIGHT TO SUE;**
4. **Release the Releasees** from any claim that such Releasees are or may be negligent in connection with my child’s use of the **Amenities**, including but not limited to injury, viral exposure, or sickness;
5. **INDEMNIFY, SAVE, AND HOLD HARMLESS** the Association, its employees, officers, board members, and agents from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with my child’s use of the **Amenities** or for any acts or omissions of the Association or other employees or agents. I will defend the Association, Management, and the Pool Company, against any suit by me, my family, any person caring for my children, and/or my heirs’ executors, administrators or assigns;
6. **The Undersigned expressly agrees that the foregoing release and waiver of liability, assumption of risk, and indemnity agreement is governed by the laws of the State of New Jersey** and is intended to be as broad and inclusive as is permitted by **New Jersey Law** and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect;
7. **Acknowledge that this document is a contract** and agree that if a lawsuit is filed against the Association, its owners, agents, officers, or employees for any injury or damage in breach of this contract, the Undersigned will pay all attorney’s fees and costs incurred by the Association, Management and the Pool Company, in defending such an action;

8. PROMISE TO ABIDE BY CDC AND STATE GUIDELINES WHILE USING THE AMENITIES, AND IN ADDITION:

- a. Keep in mind that my child is seeking to use the amenities in the middle of a pandemic. There is the risk of serious illness or death that could affect me, my children, spouse, parents, and other loved ones, especially the elderly.
- b. Every adult bringing in a child will have to sign a waiver for the child.
- c. Recognize that I am about to allow my child to engage with others, and that a child's memory for such rules as keeping distant from other children, will be short. Children may, depending upon their age, need frequent reminders.
- d. I understand that if my child is unvaccinated, my child must stay at least six (6) feet from other families, including while in the pool.
- e. I understand that if my child is unvaccinated, my child must wear a mask when not in the pool and when unable to maintain social distancing (two years of age and older).
- f. I understand that my child is encouraged to stay at least six (6) feet away from other families, regardless of their vaccination status.
- g. I understand that the Association will provide pool furniture and that my child will be responsible for wiping the furniture down when they are done using it.
- h. When using bathrooms, make sure that my child washes hands thoroughly, and then also use hand sanitizer when they leave the bathroom.
- i. Understand that there will be **NO GUESTS** from outside the community, until further notice.

9. **Acknowledge that the Association may revoke my child's privileges and permission to use the Amenities at any time, for any reason, if Association or Management deem it unsafe.** I represent and warrant that, to the best of my knowledge, my child: (a) does not now have, and have not had in the last 14 days, any symptoms related to COVID-19; and (b) has not been in direct contact with anyone who has been diagnosed with COVID-19. If my child begins to show signs or symptoms of COVID-19, they will refrain from using the Amenities. If my child tests positive for COVID-19, they will not use the Amenities. If my child tests positive for COVID-19 and they have recently used the Amenities, I will promptly make the Association aware.

IF MY CHILD ALLOWS SOMEONE TO ENTER THE AMENITY AREAS WITHOUT HAVING SIGNED A WAIVER, I WILL BE RESPONSIBLE FOR THEIR SAFETY FROM COVID-19 AND THE OTHER RISKS ASSOCIATED WITH THE USE OF THE AMENITIES. IN ADDITION, MY CHILD WILL BE BANNED FROM THE USE OF THE AMENITIES FOR 30 DAYS, AND SO WILL EACH PERSON IMPROPERLY ADMITTED. I RECOGNIZE THAT THESE RESTRICTIONS ARE INCONVENIENT AND ANNOYING, BUT I AM SEEKING TO ALLOW MY CHILD TO USE THE AMENITIES IN A PANDEMIC, AND THE ASSOCIATION CANNOT AFFORD TO BEAR THE ADDITIONAL LIABILITY THAT COMES WITH MY CHILD'S USE WHILE THERE IS A POTENTIALLY DEADLY DISEASE AROUND.

I have read this entire document. I understand it is a waiver of my/our rights, a promise not to sue, and a promise to release the Association, its owners, officers, board members, employees, and Management from all claims arising from or related to the exposure or transmission of COVID-19 and other communicable diseases. I have made a free and deliberate choice to sign this Release and Waiver as a condition to Releasees allowing my child to use the Amenities during a statewide shutdown and phased reopening during the COVID-19 Pandemic and New Jersey State response. I have concluded of my own volition that the risks involved, and the release and waiver of liability is worth the pleasure of using the Amenities.
